**WHEREAS, the Enrollment Committee is now requesting the Tohono
O'odham Legislative Council to approve the Supplemental
Budget which increased the program funds by \$7,571.32 for
Fiscal Year 1997; and**


**WHEREAS, the amount of \$7,571.32 are revenues received from the

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
Council hereby approves the Enrollment Committee
Supplemental Budget in the amount of \$7,571.32, with funds
to be appropriated from the General Revenue Funds.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative
Council on the 11TH. day of APRIL, 1997 at a meeting at which a quorum
was present with a vote of 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and
[11] ABSENT, pursuant to the powers vested in the Council by Article VI,
Section 1(d)(3) the Constitution of the Tohono O'Odham Nation, adopted
by the Tohono O'Odham Nation on January 18, 1986; and approved by the
Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March
6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
