RESOLUTION NO. 97-134

**WHEREAS, pursuant to TERO Ordinance 01-85, there is created a Tribal
Employment Rights (TERO) Commission; and**

**WHEREAS, the TERO Ordinance provides that the Commission shall be
composed of five (5) members; and**

**WHEREAS, there currently exists on the TERO Board of Commissioners
one vacancy with a two year term; and**

**WHEREAS, by public notice from the TERO Director the vacancy was
announced and the eleven districts were notified to submit
nominees for consideration; and**

**WHEREAS, at a previous Legislative Council Session, the Judiciary
Committee, having oversight, did submit the name of Phillip
Antone; and**

**WHEREAS, the Gu Vo District did also submit a letter of
recommendation on behalf of Phillip Antone; and**

**WHEREAS, the Legislative Council did accept the recommendation of
the Judiciary Committee; and**

**WHEREAS, the Legislative Council, by a standard election process, did
vote on the candidate, Mr. Phillip Antone, now submits his
name as the single candidate to the TERO Board of
Commissioners.**

5 **Commissioners.**




