

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Betsy Norris as Judge of the Tohono O'odham Courts)**

RESOLUTION NO. 97-135

WHEREAS, Section 4 of Article VIII of the Constitution of the Tohono O'odham Nation charges the Tohono O'odham Legislative Council the responsibility of appointing judges of the Tohono O'odham Courts; and

WHEREAS, a vacancy exists for one full-time judge's position to finish the six year term of former Judge Nicholas Lewis; and

WHEREAS, the Legislative Council did interview the candidates for the judge's position and reviewed their qualifications.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby appoints Betsy Norris as a full-time judge of the Tohono O'odham Courts for a six year term with said term to expire on February 01, 2001.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 14TH. day of APRIL, 1997 at a meeting at which a quorum was present with a vote of 1,734.0 FOR; -0- AGAINST; -0- NOT VOTING; and 142.0 [10] ABSENT, pursuant to the powers vested in the Council by Article VIII, Section 4 of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
