**WHEREAS, the Tohono O'odham Legislative Council did by Resolution
No. 96-351 approve the FY 1997 Projected Revenues at
\$25,780,000.00; and**

**WHEREAS, the Budget and Finance Committee is charged with the
responsibility of reviewing and recommending amendments
or modifications to annual revenue projections; and**

**WHEREAS, the Committee consulted with the Nation's Accounting
Department and has deemed it necessary to have the
approved Projected Revenues adjusted to reflect actual
revenues received todate.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
that it hereby approves the attached revised FY 97 Projected
Revenues to be increased by \$1,668,730.08 for a revised
projection of \$27,448,730.08.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative
Council on the 14TH. day of APRIL, 1997 at a meeting at which a quorum
was present with a vote of 1,734.0 FOR; -0- AGAINST; -0- NOT VOTING; and
142.0 [10] ABSENT, pursuant to the powers vested in the Council by Article
VIII, Section 4 of the Constitution of the Tohono O'Odham Nation,
adopted by the Tohono O'Odham Nation on January 18, 1986; and
approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18, 1934 (48 Stat. 984).**
