RESOLUTION NO. 97-141

**WHEREAS, the Tohono O'odham Nation has successfully operated a
program for the elderly members of the Nation; and**

**WHEREAS, funding for the operation of the Elderly Program has been
made possible in part by Title III of the Older American's Act
of 1965 as amended, through the Administration of the Inter-
Tribal Council of Arizona; and**

**WHEREAS, the services provided to elderly members has been
beneficial and services continue to be necessary to provide
nutritional and social support; and**

**WHEREAS, the Elderly Program has prepared a proposal for FY 1998
Title III funding to provide nutritional and social support
services to eligible elderly members.**

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative,

**1. that it hereby approves the proposal for Title III funding
for the Elderly Program to continue to provide such
services it has proposed per attachments in light of the
requirements and regulations.**

- 3. that the Tohono O'odham Nation's Officials to wit: the
Chairman and Vice Chairman and any designated
official are hereby authorized to negotiate and execute
the grant, provided however, that any amendments
affecting the funding or funding levels of this grant shall
be submitted for further prior approval by this Council.**

Council on the 14TH. day of APRIL, 1997 at a meeting at which a quorum
was present with a vote of 1,734.0 FOR; -0- AGAINST; -0- NOT VOTING; and
142.0 [10] ABSENT, pursuant to the powers vested in the Council by Article
VI, Section 1(f) the Constitution of the Tohono O'Odham Nation, adopted
by the Tohono O'Odham Nation on January 18, 1986; and approved by the
Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March
6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
