

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Budget Modification Number One for the Credit
and Finance Program)**

RESOLUTION NO. 97-146

WHEREAS, the Credit and Finance Program operates under the Nation's Master Contract with the United States Department of the Interior, Bureau of Indian Affairs (BIA), pursuant to Legislative Council resolution 96-281; and

WHEREAS, the Legislative Council approved, a Credit and Finance Program FY 1997 budget of \$210,001, which was based on the prior year's level of funding; and

WHEREAS, the actual FY 1997 funding allocation from BIA was \$203,200, an amount lower than that approved by Council; and

WHEREAS, the Program must modify its budget to match the FY 1997 actual allocations of funds by BIA; and

WHEREAS, the attached budget modification has been reviewed by the Executive Branch, the Commerce Committee and the Budget and Finance Committee of Legislative Council, and they have recommended that the budget modification be approved.

NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'odham Nation approves Modification Number One (attached) to the budget of the Credit and Finance Program.
