

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 1998 Weatherization Assistance Program Proposal)**

RESOLUTION NO. 97-149

WHEREAS, request for proposal applications have been made available for tribal grants for FY 1998 through the Inter Tribal Council of Arizona, Weatherization Assistance Program; and

WHEREAS, the Weatherization Assistance is available to the Tohono O'odham Nation to assist O'odham members who meet the eligibility requirements; and

WHEREAS, it is in the best interest of the Tohono O'odham Nation to request for FY 1998 Weatherization Assistance Program funds; and

WHEREAS, the Tohono O'odham Department of Human Services has submitted for review and approval of scope of work and budget that will conform to the eligibility criteria set forth in the funding and reporting regulations.

NOW, THEREFORE, BE IT RESOLVED,

- 1. That the Tohono O'odham Legislative Council does hereby authorize the officials of the Tohono O'odham Nation to submit a request for Weatherization Assistance Funding from the Inter Tribal Council of Arizona and authorizes expenditures in accordance to the attached budget.**
- 2. That the duration of the grant shall be from July 01, 1997 through June 30, 1998.**

The Tohono O'odham Nation Officials, to wit: the Chairman and Vice Chairman and any designated Official are hereby authorized to negotiate and execute the grant, provided that any amendments affecting the funding or funding levels of this grant shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 6TH. day of MAY, 1997 at a meeting at which a quorum was present with a vote of 1,809.0 FOR; 67.0 AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




