5 **1982 replacing Comprehensive Employment Training Act**
6 **(CETA); and**

8 **WHEREAS, the Job Training Partnership Act (JTPA) funds are made**
9 **available to State and Tribal Governments from the United**
10 **States Department of Labor to establish employment and**
11 **training programs for improving the employment prospects**
12 **of eligible persons; and**

14 **WHEREAS, Indian reservations in Arizona have been designated as**
15 **service delivery area and are eligible to receive Federal JTPA**
16 **funds; and**

18 **WHEREAS, the Nation is entitled to JTPA funds to develop a network of**
19 **employment training programs throughout the Nation; and**

21 **WHEREAS, the Tohono O'odham Nation has operated the Title IIB**
22 **Program since 1974; and**

23 **WHEREAS, the JTPA Program have received the funding amount from**
24 **the Department of Labor in the amount of \$372,009.00.**




