RESOLUTION NO. 97-163

WHEREAS, Low Income Home Energy Assistance funds have been made available to the Tohono O'odham Nation for FY 1998 through the State of Arizona, Department of Economic Security; and

WHEREAS, the Tohono O'odham Nation does meet the eligibility requirements to operate a Low Income Home Energy Assistance Program; and

WHEREAS, it is in the best interest of the Tohono O'odham Nation to apply for FY 1998 Low Income Home Energy Assistance funds to assist eligible families with utility assistance; and

WHEREAS, the Tohono O'odham Nation does desire to secure funding for provision of services during fiscal year 1998.

NOW THEREFORE BE IT RESOLVED,

- 1. That the Tohono O'odham Legislative Council hereby approve the proposal to the State of Arizona, Department of Economic Security for FY 1998 Low Income Home Energy Assistance funding.**
- 2. That the duration of the contract shall be from July 01, 1997 through June 30, 1998.**
- 3. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice Chairman and any designated**

18, 1934 (48 Stat. 984).**


