

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL
(Rescinding Legislative Order 96-342 and Approving the
Revised Legislative Branch Credit Card Policy)**

LEGISLATIVE ORDER NO. 97-167

**WHEREAS, the Legislative Council by Legislative Order No. 96-342 did
adopt the Legislative Branch Credit Card Policy; and**

**WHEREAS, upon further review of the Legislative Branch
Administration and the Nation's Accounting Department,
revision to the existing Credit Card Policy is necessary; and**

**WHEREAS, the Revised Credit Card Policy was reviewed by the
Legislative Rules Committee on April 17, 1997.**

**NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative
Council hereby adopts the revised Legislative Branch
Credit Card Policy.**

**BE IT FURTHER ORDERED that Legislative Order No. 96-342 is hereby
rescinded.**

**The foregoing Order was passed by the Tohono O'Odham Legislative
Council on the 9TH. day of MAY, 1997 at a meeting at which a quorum
was present with a vote of 788.0 FOR; -0- AGAINST; -0- NOT VOTING; and
1,088.0 [17] ABSENT, pursuant to the powers vested in the Council by
Section 1 (a) of Article VI and of the Constitution of the Tohono O'Odham
Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and
approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18, 1934 (48 Stat. 984).**
