RESOLUTION NO. 97-178

**WHEREAS, the Tohono O'odham Department of Human Services
presently provides Child Welfare Services through the
Division of Child Welfare; and**

**WHEREAS, the Child Welfare Services has traditionally been funded by
federal funds; and**

**WHEREAS, Federal funding has been inadequate to meet the needs of
the Nation; and**

**WHEREAS, the Nation received notification of available funding
through Indian Health Service for child protection and child
abuse prevention; and**

**WHEREAS, the Department of Human Services has developed a
proposal to provide child protection services to access the
federal funds.**

NOW, THEREFORE, BE IT RESOLVED that:

- 1. The Tohono O'odham Legislative Council hereby
approves the Child Protective and Child Abuse
Prevention proposal to be submitted to Indian Health
Service.**

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 20TH. day of MAY, 1997 at a meeting at which a quorum was present with a vote of 1,459.0 FOR; 0 AGAINST; 0 NOT VOTING; and 417.0 [10] ABSENT, pursuant to the powers vested in the Council by Article I, Section 1(f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


