

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1997 Tribal Share of COPS Grant)**

RESOLUTION NO. 97-183

WHEREAS, the Tohono O'odham Nation with a land base of 2.8 million acres and a population of 19,255 members contracts its own Law Enforcement program; and

WHEREAS, the Tohono O'odham Police Department has been awarded a COPS grant in the amount of \$199,266; and

WHEREAS, the Tohono O'odham Nation's Police Department must modify its Tribal Law Enforcement budget in support of the grant as matching shares; and

WHEREAS, the Tohono O'odham Nation's Police Department requests that the 1997 budget be modified to accommodate COPS fiscal requirements; and

WHEREAS, the Legislative Council of the Tohono O'odham Nation supports the Tohono O'odham Police Department in their request to modify their Law Enforcement budget to accommodate the COPS program.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the implementation of the proposed budget where the budget dollar amount is \$4,065,217.00.


