RESOLUTION NO. 97-213

**WHEREAS, the Ways and Means Committee of the United States House
of Representatives is considering a position to impose the
Unrelated Business Income Tax (UBIT) on Indian Gaming
revenue; and**

**WHEREAS, this would be an unprecedented position for the United
States Government to take considering its trust
responsibility to Indian Nations; and**

**WHEREAS, the Tohono O'odham Nation uses its gaming revenues for
essential governmental purposes and to generate revenues
as described in the Indian Gaming Regulatory Act, funds not
otherwise provided by the Federal Government.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation
opposes any attempts to impose the Unrelated Business
Income Tax (UBIT) on tribal government revenue and any
tribal governmental revenues.**

**BE IT FINALLY RESOLVED that the Tohono O'odham Nation's position be
forwarded to Members of Congress.**




