**RESOLUTION NO. 97-222**

**WHEREAS, the Job Training Partnership Act was enacted into law in  
1982 replacing Comprehensive Employment Training Act  
(CETA); and**

**WHEREAS, the Job Training Partnership Act (JTPA) funds are made  
available to State and Tribal Governments from the United  
States Department of Labor to establish employment and  
training programs for improving the employment prospects  
of eligible persons; and**

**WHEREAS, Indian reservations in Arizona have been designated as  
service delivery areas and are eligible to receive Federal  
JTPA funds; and**

**WHEREAS, the Nation is entitled to JTPA funds to develop a network of  
employment training programs throughout the Nation; and**

**WHEREAS, the Tohono O'odham Nation has operated the Title IIB  
Program since 1974; and**

**WHEREAS, the JTPA Program have received the funding amount from  
the Department of Labor in the amount of \$372,009.00.**

**NOW THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
Council that this Resolution supersedes Resolution No. 97-**

6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


