**WHEREAS, the Job Training Partnership Act was enacted into law in
1982 replacing the Comprehensive Employment Training Act
(CETA); and**

**WHEREAS, the Job Training Partnership Act (JTPA) funds are made
available to State and Tribal Governments from the United
States Department of Labor to establish employment and
training programs for improving the employment prospects
of eligible persons; and**

**WHEREAS, Indian reservations in Arizona have been designated as
service delivery areas and are eligible to receive Federal
JTPA funds; and**

**WHEREAS, the Nation is entitled to JTPA funds to develop a network of
employment training programs throughout the Nation; and**

**WHEREAS, the Tohono O'odham Nation has operated the Title IIA, B and
C Program since 1974; and**

**WHEREAS, the JTPA Program has received the funding amount from the
State of Arizona TSDA in the amounts of:**
