**WHEREAS, the Job Training Partnership Act was enacted into law in
1982 replacing the Comprehensive Employment & Training
Act (CETA); and**

**WHEREAS, the Job Training Partnership Act (JTPA) funds are made
available to State and Tribal Governments from the United
States Department of Labor to establish employment &
training programs for improving the employment prospects
of eligible persons; and**

**WHEREAS, Indian reservations in Arizona have been designated as
service delivery areas and are eligible to receive Federal
JTPA funds; and**

**WHEREAS, the Nation is entitled to JTPA funds to develop a network of
employment & training programs throughout the Nation;
and**

**WHEREAS, the Tohono O'Odham Nation has operated the Title IIC
program since 1974; and**

**WHEREAS, the JTPA Program have received the funding amount from
the State of Arizona/TSDA in the amounts of; \$78,778.00.**
