Tohono O'odham Psychological Services Day Treatment
Program for the Seriously Mentally Ill Tas Tonlik Ki Day
Program through a P.L. 93-638; and**

**WHEREAS, the SMI Program needs to cover salaries for the remaining
six months with carry over monies; and**

**WHEREAS, the Treatment Coordinator position will be moved to the IHS
budget and increase funds in other line items.**

NOW, THEREFORE, BE IT RESOLVED:

- 1. That the Tohono O'Odham Legislative Council hereby
approves the attached Psychological Services - SMI Day
Program Tas Tonlik Ki Day Program Budget Modification
#3 in the amount of \$295,054.00.**
- 2. The Tohono O'odham Nation's Official's to wit: the
Chairman and Vice Chairman and any designated
Official are hereby authorized to negotiate and execute
the contract, provided however, that any amendment
affecting the funding or funding levels of this contract
shall be submitted for further prior approval by this
Council.**
