(Appropriating \$100,000.00 for the Tohono O'Odham Population and
Housing Survey)**

RESOLUTION NO. 97-235

**WHEREAS, the Native American Housing Assistance Self-Determination
Act (NAHASDA) was introduced in October of 1996; and**

**WHEREAS, the NAHASDA Act revamps the present Indian Housing
Program; and**

**WHEREAS, the NAHASDA Act will create additional Self-Determination
to Tribes and provide funding under a Block Grant formula
allocation; and**

**WHEREAS, the Tohono O'Odham Nation will be required to submit a
one-year and five-year Indian Housing Plan; and**

**WHEREAS, both the Block Grant and Indian Housing Plan will require
current population and housing survey; and**

**WHEREAS, the Legislative Housing Committee and Budget and Finance
recommends approval for the request of \$100,000.00 to
conduct the Survey.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative
Council hereby authorizes the appropriation of the amount
of \$100,000.00 to complete the Tohono O'Odham Population
and Housing Survey.**

**BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative Council
hereby authorizes the appropriation from the General
Revenues Account.**


