general health and welfare of its members; and**

**WHEREAS, the Tohono O'odham Nation has operated the FPP - Family
Preservation and Support Services, Title IV-B, Subpart II
through the Department of Human Services (DHS) and Child
Welfare Division (CWD) under the grant with the
Department of Health and Human Services administration
through the Administration for Children Youth and
Families; and**

**WHEREAS, notification was received from the Administration for
Children, Youth and Families of an increase to the FY1997
budget in the amount of \$1,261.**

THEREFORE, BE IT RESOLVED THAT:

- 1. The Tohono O'odham Legislative Council has reviewed
and hereby approves the attached Family Preservation
and Support Services, Title IV-B, Subpart II, FY1997,
Budget modification #1 increase by \$1,261.**
- 2. That the Tohono O'odham Nation will not fund or
operate the program in the interim while negotiations**

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 20TH. day of JUNE, 1997 at a meeting at which a quorum was present with a vote of 1,785.0 FOR; -0- AGAINST; -0- NOT VOTING; and 142.0 [06] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
