**RESOLUTION NO. 97-246**

**WHEREAS, the Tohono O'odham Nation has concerns for the general health and welfare of the O'odham; and**

**WHEREAS, the Tohono O'odham Nation is currently operating the Parenting Skills Training Program through the Department of Human Services/Division of Child Welfare under a contract with the State of Arizona, Department of Health Services; and**

**WHEREAS, notification was received from the State of Arizona Department of Health Services on funding allowance level of 25% for fringe benefits on the Parenting Skills Training Program Contract.**

**NOW, THEREFORE, BE IT RESOLVED THAT:**

- 1. The Tohono O'odham Legislative Council has reviewed and hereby approves the attached Parenting Skills Training Program budget modification #1 for FY 1998 to decrease fringe benefits line item amount of 32% to 25%.**
- 2. That the Tohono O'odham Nation will not fund or operate the program in the interim while negotiations are being conducted and no executed contract has been**

3. The Tohono O'odham Nation officials, to wit: the Chairman and Vice Chairman and any designated Official are hereby authorized to negotiate and execute this contract.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 20TH. day of JUNE, 1997 at a meeting at which a quorum was present with a vote of 1,785.0 FOR; -0- AGAINST; -0- NOT VOTING; and 142.0 [06] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(f) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
