RESOLUTION NO. 97-247

WHEREAS, the Tohono O'odham Nation has operated a Head Start Program to provide and serve educational and preschool learning experiences for children ages 3 - 5; and

WHEREAS, the Department of Health and Human Services, Administration for Children and Families has provided supplemental funds for (1) Quality Improvement (2) Transition (3) Cost of Living Adjustment (4) FY 95 Carry Over Funds; and

WHEREAS, the Head Start has prepared funding proposals to be submitted to the Department of Health and Human Services, Administration of Children and Families.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative does hereby approve the Head Start Supplemental Grant Proposals for (1) Quality Improvement (2) Transition (3) Cost of Living Adjustment; and (4) FY 95 Carry Over Funds in the amount of \$226,711.00.

BE IT FURTHER RESOLVED that the duration of the budget will be from November 01, 1996 through October 31, 1997.
