**WHEREAS, the Tohono O'odham Nation has recognized the importance
of Head Start Education and stimulation; and**

**WHEREAS, the Tohono O'odham Nation has operated a Head Start
Program to provide pre-school learning and experiences for
the children ages 3 - 5 years; and**

**WHEREAS, the Head Start Program has prepared a request for Quality
Improvement Training Funds from the Grantee Agency to
conduct Quality Improvement Training for the Head Start
staff and parents, on August 10 - 13, 1997 in Tucson, Arizona.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
Council that it does hereby approve the proposed Quality
Improvement Training Funds for FY 1997 for the Tohono
O'odham Early Childhood Head Start in the amount of
\$11,495.00.**

**BE IT FURTHER RESOLVED that the duration of the budget will be from
November 01, 1996 through October 31, 1997.**

that the Tohono O'odham Nation's Officials wit: Chairman,
Vice-Chairman and any designated official are hereby**
