4 **WHEREAS, the Secretary of Interior bears the responsibility for the**  
5 **completion of designs and construction of facilities for the**  
6 **Schuk Toak new farm project under the Southern Arizona**  
7 **Water Rights Settlement Act of 1982; and**

8 **WHEREAS, the Tohono O'Odham Nation did enter into a four-year P.L**  
9 **93-638 Grant Agreement (6-FG-32-00100) to complete**  
10 **construction of the farm projects during 1996-1999; and**

11  
12 **WHEREAS, the Nation's Water Projects Office developed four-year**  
13 **projections for direct and indirect costs associated with**  
14 **construction and administration efforts under the P. L. 93-**  
15 **638 Grant Agreement totaling \$23,374,714.00; and**

16  
17 **WHEREAS, portions of the scope of work originally identified for 1996**  
18 **were not completed and are incorporated into 1997 as**  
19 **reflected in the attached modification; and**

20  
21 **WHEREAS, the attached modification proposes to utilize funds**  
22 **remaining from previous years to complete the scope of**  
23 **work in subsequent program years. The aggregate amount**  
24 **of \$23,374,714.00 is not changed by this modification.**

25 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative**  
26 **Council that it hereby approves that funds remaining from**

**BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative Council  
hereby authorizes the Executive Office and the Water  
Projects Office to continue to negotiate with the Secretary of  
Interior, or his agents, to achieve full funding for the  
completion of construction of the Schuk Toak farm project,  
and further authorizes and directs the Chairman of the  
Nation to execute any modification to the Grant Agreement  
for the completion of construction of the Schuk Toak new  
farm during 1996 - 1999.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative  
Council on the 20TH, day of JUNE, 1997 at a meeting at which a quorum  
was present with a vote of 1,153.0 FOR; 442.0 AGAINST; 190.0 NOT VOTING;  
and 142.0 [06] ABSENT, pursuant to the powers vested in the Council by  
Article VI, Section 1(f) of the Constitution of the Tohono O'Odham Nation,  
adopted by the Tohono O'Odham Nation on January 18, 1986; and  
approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18, 1934 (48 Stat. 984).**
