6 **revenues generated in the conduct of the 59th Annual Rodeo**
7 **& Fair held on February 7, 8, and 9, 1997 would be utilized by**
8 **the Rodeo & Fair Committee; and**

10 **WHEREAS, the agreement was in the form of a letter of Authorization**
11 **signed by the Chairman of the Legislative Council, dated**
12 **January 29, 1997.**

15 **The Rodeo & Fair Committee is authorized to utilize**
16 **and expend any and all funds received from sponsors,**
17 **donors and sales to supplement funds allocated to the**
18 **Nation. All accounting transactions of funds received**
19 **will be maintained by the Nation's Accounting**
20 **Department. A full report from the Rodeo & Fair**
Committee, along with he Accounting Department will
be provided at the March General Session.

21 **WHEREAS, the Rodeo & Fair Committee and the Accounting Department**
22 **did provide a report to the Legislative Council on March 7,**

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 20TH day of JUNE, 1997 at a meeting at which a quorum was present with a vote of 1,434.0 FOR; -0- AGAINST; -0- NOT VOTING; and 493.0 [10] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(3) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


