

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointing Judge Pro Tempore of the Tohono O'odham Courts)**

**RESOLUTION NO. 97-277**

**WHEREAS, the Legislative Council is empowered by Article VIII, Section 4 of the Constitution of the Tohono O'odham Nation to appoint judges of the Tohono O'odham Courts; and**

**WHEREAS, the Legislative Council did by Ordinance No. 01-89, Chapter II, authorized the appointment of judges pro tempore to the Tohono O'odham Courts upon the recommendation of the Chief Judge; and**

**WHEREAS, the Chief Judge has submitted the names of attorneys qualified pursuant to 2-103 of Ordinance of No. 01-89 and recommended their appointment as judges pro tempore of the Tohono O'odham Courts; and**

**WHEREAS, Resolution No. 95-208 appointed Judith Dworkin as judge pro tempore for a term of 2 years; and**

**WHEREAS, the term of Judge Pro Tempore, Judith Dworkin expired effective May 1, 1997; and**

**WHEREAS, the Chief Judge has submitted the name of Judith Dworkin who he believes to be qualified to fill the current expired term; and**

**WHEREAS, the Judiciary Committee has met with the Chief Judge and**

**WHEREAS, the Judiciary Committee has determined that the person recommended is of good moral character, a resident of the State of Arizona for not less than five years, and is admitted to the practice of law for not less than three years; and**

**WHEREAS, the Judiciary Committee does concur with the recommendation of the Chief Judge and recommends to the full Legislative Council the appointment of Judith Dworkin as Judge Pro Tempore for the Judicial Branch of this Nation.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does accept the recommendation of the Chief Judge and in accordance with Judicial Branch Rules and Procedures formally adopted by this Legislative Council by Ordinance 01-89, hereby appoints Judith Dworkin as Judge Pro Tempore of the Tohono O'odham Judicial Branch for a period which shall expire on the 1<sup>st</sup> day of May, 1999.**

**BE IT FURTHER RESOLVED that the appointment of the foregoing named person shall become effective on the 10<sup>th</sup> day of July 1997, for the period designated.**
