**WHEREAS, the Tohono O'odham Nation's Solid Waste Program supplemental budget was approved by the Executive Review Committee.**

**NOW, THEREFORE, BE IT RESOLVED that the funds identified in the attached adjusted Solid Waste Program Supplemental Budget be approved for expenditures accordingly.**

**BE IT FURTHER RESOLVED that funds will be appropriated from the General Revenue Account.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10TH, day of JULY, 1997 at a meeting at which a quorum was present with a vote of 1,781.0 FOR; -0- AGAINST; -0- NOT VOTING; and 146.0 [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
