6 **WHEREAS, during the July 8, 1997 General Session of the Tohono**
7 **O'odham Legislative Council, the Legislative Council did**
8 **pass Resolution No. 97-272 "Removing the Tohono O'odham**
9 **Housing Authority's Board of Commissioners and**
10 **Appointing the Legislative Housing Committee to serve as**

13 **WHEREAS, upon presentation of Resolution 97-272 to the Chairman of**
14 **the Tohono O'odham Nation, he did disapprove thereof and**
15 **returned it to the Council with his objections in accordance**
16 **with the provisions of Article VII, Section 5 of the**
17 **Constitution of the Tohono O'odham Nation; and**

20 **WHEREAS, upon further discussion of the vetoed resolution during the**
21 **July 11, 1997 Legislative Session, the Chairman of the Nation**
22 **presented his justifications in vetoing Resolution 97-272 (a**
23 **copy of which is hereto attached); and**

25 **WHEREAS, the Tohono O'odham Legislative Council has reviewed the**
26 **Chairman's objections and after consideration, again voted**

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby override the Chairman's veto of Resolution No. 97-272 by a vote of two-thirds (2/3) of the votes cast.

The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on the 11TH. day of JULY, 1997 at a meeting at which a quorum was present with a vote of 817.0 FOR; 774.5 AGAINST; 335.5 NOT VOTING; and [03] ABSENT, failed to pass because it did not receive a two-thirds (2/3) [1,061.0] of the votes cast as required by Section V of Article VII of the Constitution of the Tohono O'Odham Nation.
