WHEREAS, during the July 8, 1997 General Session of the Tohono O'odham Legislative Council, the Legislative Council did pass Resolution No. 97-272 "Removing the Tohono O'odham Housing Authority's Board of Commissioners Appointing the Legislative Housing Committee to serve as Interim Board": and

> upon presentation of Resolution 97-272 to the Chairman of the Tohono O'odham Nation, he did disapprove thereof and returned it to the Council with his objections in accordance with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'odham Nation; and

WHEREAS, upon further discussion of the vetoed resolution during the July 11, 1997 Legislative Session, the Chairman of the Nation presented his justifications in vetoing Resolution 97-272 (a copy of which is hereto attached); and

WHEREAS, the Tohono O'odham Legislative Council has reviewed the Chairman's objections and after consideration, again voted to pass Resolution No. 97-272.
