funds from certified accountants; and**

**WHEREAS, the Sif-Oidak District does have sufficient funds in the  
current budget to cover for approximately 2 months at  
which time final result of all accounts will be in order.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
Council does hereby support and approve the continuation  
of the current budget for Fiscal Year 1996-97.**

**BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council  
supports the identified signers of the account for proper  
expenditures.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative  
Council on the 17TH. day of JULY, 1997 at a meeting at which a quorum  
was present with a vote of 1,785.0 FOR; -0- AGAINST; -0- NOT VOTING; and  
142.0 [6] ABSENT, pursuant to the powers vested in the Council by Section  
1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation,  
adopted by the Tohono O'Odham Nation on January 18, 1986; and  
approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18, 1934 (48 Stat. 984).**




