**RESOLUTION NO. 97-293**

**WHEREAS, the Legislative Council is aware of the APS Transmission line  
that runs through the Sif-Oidak District; and**

**WHEREAS, the Sif-Oidak District Council has approved the second 25-  
year renewal of right-of-way for the APS transmission line;  
and**

**WHEREAS, B.I.A. (Bureau of Indian Affairs) will deposit into the Sif-  
Oidak District account for the initial 8 year period**

<b>Easement Value</b>	<b>\$ 70,000.00</b>
<b>One Time Adjustment</b>	<b><u>40,000.00</u></b>
<b>Total</b>	<b><u>\$100,000.00</u></b>

**\$4,000.00 will be reimbursed to the Tohono O'odham Nation.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
Council supports and approves the 25-year renewal of the  
APS Right-Of-Way Agreement.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative  
Council on the 17TH day of JULY, 1997 at a meeting at which a quorum  
was present with a vote of 1,226.0 FOR; 407.0 AGAINST; 152.0 NOT VOTING;  
and 142.0 [05] ABSENT, pursuant to the powers vested in the Council by  
Section 2(d) of Article VI of the Constitution of the Tohono O'Odham  
Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and  
approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18, 1934 (48 Stat. 984).**
