(Bureau of Indian Affairs) will deposit into the Sif-11 Oidak District account for the initial 8 year period 12 13 \$ 70,000.00 **Easement Value One Time Adjustment** 40.000.00 14 \$100,000.00 **Total** 15 \$4,000.00 will be reimbursed to the Tohono O'odham Nation. 16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative 17 18 Council supports and approves the 25-year renewal of the 19 **APS Right-Of-Way Agreement.** 20 The foregoing Resolution was passed by the Tohono O'Odham Legislative 21 Council on the 17TH, day of JULY, 1997 at a meeting at which a quorum 22 was present with a vote of 1,226.0 FOR; 407.0 AGAINST; 152.0 NOT VOTING; and 142.0 [05] ABSENT, pursuant to the powers vested in the Council by Section 2(d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). 26 27
