**WHEREAS, the following communities and districts have requested
funding of the specified Projects:**

**WHEREAS, the above listed communities and the recipients in those
communities seek to receive rehabilitation to be funded
under HUD-ICDBG for 1997; and**

**WHEREAS, the ICDBG grant criteria require all houses rehabilitated
under the program must be brought up to standard
condition; and**

WHEREAS, the grant ceiling on a per unit basis is \$35,000/home; and

**WHEREAS, each recipient home needs a foundation to be brought up to
standard and meet the grant requirements; and**

WHEREAS, the cost of foundations takes some of the recipient homes beyond the grant ceiling of \$35,000 per unit;

WHEREAS, the ICDBG program allows for a mix of funds from different sources to bring a home up to standard, provided the ICDBG portion does not exceed \$35,000 per unit and the house is suitable for rehabilitation and not demolition; and

WHEREAS, the Tohono O'odham Nation commits to funding the cost of foundations for some of the homes submitted in the 1997 ICDBG application, which is a cost of \$56,621.00.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation does certify and commit \$56,621.00 to the cost of providing foundations for the homes to be rehabilitated under the 1997 ICDBG program, contingent upon receiving the grant award from HUD-ICDBG.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 21ST. day of JULY, 1997 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
