**RESOLUTION NO. 97-304**

**WHEREAS, the Tohono O'odham Legislative Council has a need for legal advice and representation on matters in which the Office of Attorney General has a conflict of interest or the Attorney General has insufficient resources to provide the legal services requested; and**

**WHEREAS, an Attorney Contract with the law firm of Korn, Waterman & Simon has been proposed to secure the legal services not available through the Office of Attorney General for the foregoing reasons, a copy of which is attached hereto; and**

**WHEREAS, the approved budget of the Legislative Council for fiscal year 1997 has available funding sufficient to pay all fees and expenses under the Attorney Contract.**

**NOW, THEREFORE, BE IT RESOLVED THAT:**

- 1. The Attorney Contract with the law firm of Korn, Waterman & Simon is hereby approved by the Tohono O'odham Legislative Council, in the form attached hereto, in the amount of \$15,000 for the period from July 09, 1997 through September 30, 1997.**

2. All fees and expenses incurred under the Attorney Contract shall be payable from the approved budget of the Legislative Council for fiscal year 1997.
3. The Chairman of the Legislative Council and the Chairman of the Nation are authorized and directed to execute the Attorney Contract.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 21ST day of JULY, 1997 at a meeting at which a quorum was present with a vote of 1,721.0 FOR; 60.0 AGAINST; -0- NOT VOTING; and 146.0 [07] ABSENT, pursuant to the powers vested in the Council by Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


