NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Consulting Contract with the Crawford Computer Consulting is hereby approved by the Tohono O'odham Legislative Council, in the form attached hereto, in the amount of \$5,000.00 for \$50.00 an hour not to exceed 100 hours.**
- 2. All fees incurred under the Consulting Contract shall be payable from the approved budget of the Tohono O'odham Survey Budget.**
