

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Early Childhood Head Start/Proposal Budget FY 1998
November 01, 1997 - October 31, 1998)**

RESOLUTION NO. 97-312

WHEREAS, the Tohono O'odham Nation has operated a Head Start Program to provide and serve educational and preschool learning experiences for children ages 3-5; and

WHEREAS, the Department of Health and Human Services, Administration for Children and Families has provided funds for the continued operation of the Head Start program; and

WHEREAS, the Head Start Program has prepared a funding proposal to be submitted to the Department of Health and Human Services, Administration of Children and Families & American Indian Programs Branch for the continued operation of the Head Start Program to eligible and qualifying applicants.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby review and approve the Head Start FY 1998 Budget amount of \$1,161,269.00.

BE IT FURTHER RESOLVED that the duration of the budget will be from November 01, 1997 through October 31, 1998.


BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the grant, provided however, that any amendments affecting the funding or

funding levels of this grant shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 31ST day of JULY, 1997 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [10] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
