**WHEREAS, the Tohono O'odham Nation established the Tohono O'odham
Fire Department in 1995 to provide fire protection and fire
safety to all members of the Nation; and**

**WHEREAS, the Tohono O'odham Fire Department has come before the
Tohono O'odham Legislative Council and requested approval
of a budget modification #2 which includes the Capital line
item in the amount of \$16,000.00.**

**WHEREAS, the Capital line item was not included in the base budget and
approved supplemental budgets.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
Council recommends the approval of the budget modification
#2 request with the Capital line item included for the Tohono
O'odham Nation Fire Department and be included as part of
the base FY 97 budget.**

**BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council
hereby approves the supplemental FY 97 budget modification
request for the Tohono O'odham Nation Fire Department.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative
Council on the 31ST, day of JULY, 1997 at a meeting at which a quorum
was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and
