**WHEREAS, the Tohono O'odham Nation Legislative Council approved the  
Tohono O'odham Fire Department's supplemental budget  
request in the amount of \$158,294.00 per Resolution No. 97-137  
approved on April 16, 1997; and**

**WHEREAS, the Nation's Chairman approved the supplemental budget on  
April 17, 1997. The additional funds will be utilized to continue  
to provide fire protection and safety to all members of the  
Nation; and**

**WHEREAS, the Tohono O'odham Fire Department is hereby requesting  
that the approved supplemental budget of \$158,294.00 to be  
included as part of the FY-97 base budget of which the amount  
is \$598,224.92 for the Fire Department; this will bring the total  
amount of funds to be utilized as the base budget to  
\$756,518.92; and**

**WHEREAS, the Commerce and Budget & Finance Committees of the  
Legislative Council recommends the approval of the inclusion  
of the FY97 Supplemental Budget to the FY97 base budget for  
the Tohono O'odham Nation Fire Department.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 31ST day of JULY, 1997 at a meeting at which a quorum was present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [10] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
