**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
Council that it does hereby recognize that the above-named  
person(s) have relinquished their membership in this Nation,  
and does hereby order that their name(s) be deleted from the  
membership roll.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative  
Council on the 4TH. day of AUGUST, 1997 at a meeting at which a quorum  
was present with a vote of 1,846.5 FOR; 80.5 AGAINST; -0- NOT VOTING;  
and [02] ABSENT, pursuant to the powers vested in the Council by Article  
II, Section 3 and Article IV, Section 1(h) of the Constitution of the Tohono  
O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,  
1986; and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
June 18, 1934 (48 Stat. 984).**
