**WHEREAS, the Job Training Partnership Act Program has brought forth a
modification to the existing Title IIB Department of Labor base
budget; and**

**WHEREAS, the modification reflects a decrease in the total program budget
amount from \$316,208.00 to \$240,742.00, a reduction of
\$75,466.00; and**

**WHEREAS, this reduction is reflective of changes in carry in amounts
which have already been spent and that the base allocation
amount still remains the same.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
Council that it does hereby approve the FY97 JTPA Title IIB/DOL
budget modification #1 program budget.**

the 7TH. day of AUGUST, 1997 at a meeting at which a quorum was
present with a vote of 1,766.0 FOR; -0- AGAINST; -0- NOT VOTING; and
1610.0 [05] ABSENT, pursuant to the powers vested in the Council by
Section 1(f) of Article VI of the Constitution of the Tohono O'Odham
Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and
approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18, 1934 (48 Stat. 984).**


