**RESOLUTION NO. 97-337**

**WHEREAS, the Legislative Council of the Tohono O'odham Nation has  
authorized modification to the existing ITCA Solid Waste  
Program Budget; and**

**WHEREAS, the existing ITCA Solid Waste Program Budget has been  
modified to reflect additions between their operating budget  
line items and the addition of line item 751 Lease Rentals.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
Council of the Tohono O'odham Nation hereby approves  
budget modification #3 to the ITCA Solid Waste Program's  
Budget.**

**The foregoing Resolution was passed by the Tohono O'odham Council on  
the 8TH day of AUGUST, 1997 at a meeting at which a quorum was  
present with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [03]  
ABSENT, pursuant to the powers vested in the Council by Section 1(f) of  
Article VI of the Constitution of the Tohono O'Odham Nation, adopted by  
the Tohono O'Odham Nation on January 18, 1986; and approved by the  
Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March  
6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
