**WHEREAS, the Tohono O'odham Nation is presently operating the Early Childhood Head Start by providing for their welfare through various programs and services designed to meet their welfare through various programs and services designed to meet their special needs; and**

**WHEREAS, the Department of Health and Human Services, Administration for Children and Families has awarded to the Tohono O'odham Nation appropriations under the Omnibus Budget Reconciliation Act of 1990, P.L. 101-508 and the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, P.L. 104-193, to conduct a Child Care and Development Fund Program; and**

**WHEREAS, the Tohono O'odham Nation Early Childhood Head Start Program has submitted for review and approval the proposed Child Care and Development Fund budget for FY 1998 in the amount of \$367,088.00.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby approve the FY 1998 Child Care and Development Fund budget for the period 10/01/97 thru 09/30/98 in order to provide Day Care services for its young tribal members.**
