**RESOLUTION NO. 97-343**

**WHEREAS, the Tohono O'odham Nation is currently funding Senior  
Services Programs through tribal funds; and**

**WHEREAS, a budget modification is necessary to address program and  
service needs; and**


**WHEREAS, a budget has been submitted which does not change the  
funding level but does change line item amount to address  
current needs.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
Council that it hereby approves 1997 Senior Services base  
budget modifications and authorizes expenditures in  
accordance with the attached budget modification.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the  
20TH. day of AUGUST, 1997 at a meeting at which a quorum was present with  
a vote of 1,781.0 FOR; -0- AGAINST; -0- NOT VOTING; and 146.0 [09] ABSENT,  
pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI  
of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
O'Odham Nation on January 18, 1986; and approved by the Acting Deputy  
Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant  
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
