**WHEREAS, the term of Madeline Sakiestewa as Member of the Board of
Commissioners of the Tohono O'Odham Housing Authority
("TOHA") expired on August 15, 1997; and**

**WHEREAS, TOHA Commissioners Ned Norris, Jr., John Fendenheim,
Shirley Manuel, and Linda Preston have each submitted his or
her resignation as Member of the Board of Commissioners of
TOHA.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
Council that the resignations of TOHA Commissioners Ned
Norris, Jr., John Fendenheim, Shirley Manuel, and Linda
Preston are hereby accepted.**

**BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Housing
Committee shall serve as the Interim Board of Commissioners
until the Tohono O'odham Nation designates a Tribally
Designated Housing Entity (TDHE).**

**The foregoing Resolution was passed by the Tohono O'odham Council on the
26TH. day of AUGUST, 1997 at a meeting at which a quorum was present with
a vote of 1,595.0 FOR; 139.0 AGAINST; 73.0 NOT VOTING; and 120.0 [08]
ABSENT, pursuant to the powers vested in the Council by Section 1(b) & (e)
of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by
the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
