**RESOLUTION NO. 97-352**

**WHEREAS, the Tohono O'odham Nation is presently operating the Project  
2000 under a Tribal Base Budget; and**

**WHEREAS, the budget modification is necessary to address program and  
service needs; and**

**WHEREAS, a budget modification has been submitted which does not  
change the funding level, but does change line item amounts  
to address current needs.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
Council that it hereby approves the amendment to the Project  
2000 and authorizes expenditures in accordance with the  
attached budget modification.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the  
8TH. day of SEPTEMBER, 1997 at a meeting at which a quorum was present  
with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [02] ABSENT,  
pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI  
of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
O'Odham Nation on January 18, 1986; and approved by the Acting Deputy  
Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant  
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
