

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Department of Human Services - Management of
Health Fiscal Year 1997 Base Budget Modification No. 1)**

RESOLUTION NO. 97-353

**WHEREAS, the Tohono O'odham Nation is presently operating the FY 1997
contracts with the Indian Health Services; and**

**WHEREAS, such tribal operations have been successful and beneficial to
the Tohono O'odham Nation and its people; and**

**WHEREAS, the Department of Human Services does desire to modify the
Management of Health fiscal year budget to increase line items
and add a capital equipment line item; and**

**WHEREAS, the budget modification is necessary to address program needs
and services; and**

**WHEREAS, the Department of Human Services also desires to utilize
\$36,793 of the \$70,000 Management of Health contract
carryover funds to increase the budget.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
Council that it authorizes approval of the Management of
Health Budget Modification No. 1 to increase the budget to a
total of \$268,082.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the
8TH. day of SEPTEMBER, 1997 at a meeting at which a quorum was present
with a vote of 1,927.0 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT,
pursuant to the powers vested in the Council by Section 1(f) of Article VI of
the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
