

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

RESOLUTION NO. 97-354

WHEREAS, the Tohono O'odham Nation is presently operating the Weatherization Assistance Program through the Inter-Tribal Council of Arizona; and

WHEREAS, any amendments affecting the funding or funding levels of the contract shall be submitted for review and approval by the Tohono O'odham Legislative Council; and

WHEREAS, the Nation has amended the Memorandum of Agreement with the Inter-Tribal Council of Arizona to extend the project period from July 01, 1996 through June 30, 1998; and

WHEREAS, an amendment has been submitted for review and approval by the Weatherization Assistance Program.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 1. It hereby approves the amendment and authorizes expenditures in accordance with the attached budget modification no. 1 submitted by the Weatherization Assistance Program.**
- 2. The Tohono O'odham Nation's Officials, to wit; the Chairman and Vice Chairman and any designated Official are hereby authorized to negotiate and execute the grant, provided that any amendment affecting the funding or**
