continuing this program for the benefit of its young members.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
Council that it does hereby approve the proposed FY 1998
Tohono O'odham Day Care Services Title XX Budget
Modification #1 with an increase in funding in the amount of
\$146,324.00.**

**BE IT FURTHER RESOLVED that the duration of the budget will be from July
01, 1997 through June 30, 1998.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that
the Tohono O'odham Nation's Officials, to wit; the Chairman
