RESOLUTION NO. 97-369

WHEREAS, there is pending before the Arizona United States District Court a consolidated civil action related to the Nation's legal claims arising out of the Meadowood Ranch transactions and associated matters: Tohono O'odham Nation v. Dutari, et al., CIV 94-547-TUC-FRZ (D. Ariz.) (the "Arizona Federal Lawsuit"); and

WHEREAS, there is pending before the Ninth Circuit Court of Appeals an appeal filed by the Nation challenging certain rulings by the Court in the Arizona Federal Lawsuit (the "Federal Appeal"); and

WHEREAS, pursuant to an Attorney Contract, as modified by Amendment Nos. 1 and 2, the law firm of Fines & Oden serves as co-counsel with the Attorney General in the Arizona Federal Lawsuit and the Federal Appeal; and

WHEREAS, the Attorney Contract and authorization to expend the Contract amount appropriated for this fiscal year expire on September 30, 1997; and

WHEREAS, the current Contract amount was appropriated for fiscal year 1997 from the Meadowood Litigation Account (No. 01-1019-810); and

WHEREAS, the unexpended balance in the Meadowood Litigation Account is approximately \$215,781 as of August 21, 1997; and

WHEREAS, the Attorney General has requested an extension of the Attorney Contract for fiscal year 1998 and the appropriation of the unexpended balance in the Meadowood Litigation Account on September 30, 1997 to pay fees and expenses under the extended Contract; and

WHEREAS, the Domestic Affairs and the Budget & Finance Committees recommend approval of the requested Contract extension and appropriation.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Tohono O'odham Legislative Council hereby approves Amendment No. 3 to the Attorney Contract with the law firm of Fines & Oden, in the form attached hereto, which extends the term of the Contract through September 30, 1998.**
- 2. The Legislative Council further appropriates the unexpended balance of the Meadowood Litigation Account as of September 30, 1997 to pay the fees and expenses under the Attorney Contract for fiscal year 1998.**
- 3. The Chairman of the Nation is authorized and directed to execute Amendment No. 3 to the Attorney Contract.**
