

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of Addendum No. 1 to the Professional Services  
Contract Between Korn, Waterman and Simon and the  
Tohono O'Odham Nation)**

**RESOLUTION NO. 97-374**

**WHEREAS, the Tohono O'odham Nation entered into a Professional Services Contract with Korn, Waterman and Simon for Attorney Services to the Legislative Council with a total contract amount of \$15,000.00 per Tohono O'Odham Legislative Council Resolution No. 97-304; and**

**WHEREAS, additional funds are needed in addition to the original contract amount; and**

**WHEREAS, the officers of the Legislative Council recommend that the contract amount be increased by \$13,898.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council approves Addendum No. 1 to the Professional Services Contract between Korn, Waterman and Simon and the Tohono O'Odham Nation in the form attached hereto, providing an increase of \$13,898 in the contract amount for a total contract amount of 28,898 to be paid from Account No. 01-1002-810 and authorizes the Chairman of the Nation and the Chairman of the Legislative Council to sign the Addendum.**

**The foregoing Resolution was passed by the Tohono O'odham Council on the 11TH day of SEPTEMBER, 1997 at a meeting at which a quorum was present with a vote of 1,781.0 FOR; -0- AGAINST; -0- NOT VOTING; and 146.0 [08] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of**
