WHEREAS, the Tohono O'odham Nation through its membership participated in the development and establishment of the National Indian Health Board to improve the delivery of health care for all American Indians, and continues to advocate on behalf of all federally recognized tribes in the developed of national Indian health policy; and

WHEREAS, the Tohono O'odham Nation has had representation on the National Indian Health Board as Tucson Area Representatives since its establishment in 1972 for the past twenty-five years; and

WHEREAS, the Tohono O'odham Nation does acknowledge the years of service and dedication the Tucson Area representatives served to advocate for health care improvement to strengthen the role of tribes and participation in health care legislation that has had an impact on the delivery of health care.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves funds in the amount of \$5,304.75 to be utilized for travel expenses for five (5) former O'odham National Indian Health Board Tucson Area members to attend the 15th Annual NIHB Consumer Conference to be held on
